## **Ask Applicants About Criminal Background**

Here's a Model Form we prepared with the help of Kay McIlmoil of VOA National Housing Corp. and Vikki Gherzi of G & K Management Co. Show it to your attorney, and adapt it for use at your site so you'll get the information you need to comply with HUD's one-strike rule and screen out applicants with certain criminal and sex offender backgrounds.

The form explains why you're asking about criminal backgrounds and makes clear that applicants must answer your questions to live at your site. The form then asks three specific questions about the applicant's background to determine whether the applicant meets the mandatory screening criteria involving drug-related evictions, drug and alcohol abuse, and sex offender status. It goes on to ask other questions that might apply at your site, depending on what optional screening criteria you've adopted.

The last two questions ask applicants about other states they've lived in and other names they've used so that you can run criminal and sex offender background checks. Finally, the form asks for the applicant's consent to run these background checks. AHMI0046
